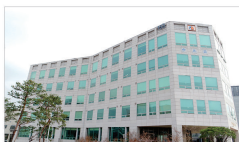


ITPOs worldwide: 9 offices in 8 countries

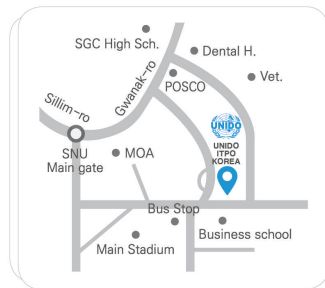

- Matching potential investors in Korea with delegates from developing countries;
- Evaluate the efficiency and feasibility of promising investment projects in developing countries;
- Identify and develop industrial cooperation projects in developing countries, capitalizing on Korean government's Official Development Assistance (ODA) projects.

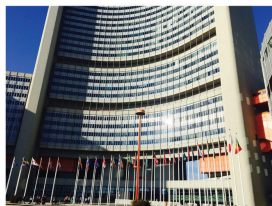

WHO WE ARE

The United Nations General Assembly passed resolution 2152 establishing UNIDO as an autonomous body within the UN in 1966. UNIDO became a specialized agency of the UN in 1985. UNIDO has been supporting developing countries to reduce poverty and enhance their economic capacity through industrial development, trade capacity-building, and eco-friendly development. To achieve these, UNIDO actively carries out technical cooperation, policy advisory services, normative functions/standards and quality-related activities.



UNIDO and SDGs(Sustainable Development Goals)

The mission of the UNIDO is to promote Inclusive and Sustainable Industrial Development (ISID) to achieve the SDGs. In particular, to attain SDG 9 (Build resilient infrastructure, promote inclusive and sustainable industrialization and foster innovation), UNIDO focuses on the following four strategic priorities;

- Creating shared prosperity / Advancing economic competitiveness /
- Safeguarding the environment / Strengthening knowledge and institutions.

ISID implies that no one is left behind and all parts of society benefit from industrial progress, which also provides the means for tackling critical social and humanitarian needs.

UNIDO Network

UNIDO is headquartered in Vienna and maintains a field network comprising of 47 regional and country offices around the world. UNIDO has offices in Brussels, Geneva and New York to maintain close cooperation relationship with the UN, EU, and other IOs. UNIDO also operates a regional cooperation centre in Turkey. Several centres National Cleaner Production Centres(NCPCs), International Technology Centres(ITCs), AfriPANet(Africa Investment Promotion Agency Network), Centres for South-South Industrial Corporation, SPXs(Subtracting and Partnership Exchanges) are operational under UNIDO.

Delegate Programme

UNIDO ITPO Korea invites high-level officials of public/private Investment Promotion Agencies (IPAs) or industrial experts from developing countries to Korea. The Delegate Programme consists of bilateral business meetings with potential Korean investors, country presentations, and industrial tours. The programme serves as a gateway to launching substantive cooperation between Korean private sectors and partner countries.

Trade & Investment Seminar

UNIDO ITPO Korea arranges seminars in collaboration with various stakeholders such as Korean government authorities, potential investors, relevant organizations in developing countries, and UNIDO regional offices. The seminars are designed to share substantial information on partner countries' investment environment, demand, and cases and to provide opportunities for establishing business networks.

Advisory Programme – Ethiopia, Cambodia, and Peru

UNIDO ITPO Korea employs and assigns local advisors to Ethiopia, Cambodia and Peru. The advisors continuously provide potential Korean investors with the latest information on their local investment environment to facilitate technology transfer, cooperation on investment and industry. Based on the consulting services, financial and technological resources will be mobilized from Korea to the three target countries.

Industrial Inspection Tours

To promote industrial cooperation and activate technology transfer between Korea and developing countries, UNIDO ITPO Korea arranges periodical Industrial Tours by diplomats residing in Korea on industrial facilities that exhibit advanced technologies. UNIDO ITPO Korea focuses on such thematic areas as clean technology, industry cluster upgrading, and other environment related industries.

COMFAR III(COMFAR III Workshop)

COMFAR is a computer software programme developed by UNIDO to facilitate financial and economic appraisal of an investment project and to reduce investment risks. UNIDO ITPO Korea provides COMFAR software training seminars to potential Korean investors to help them develop COMFAR usage skills and increase the efficiency of investment feasibility study.

Technology Database

A database of enterprises interested in transferring their own technology and/or investing in developing countries will be built in order to provide opportunities for business partnerships. The database will raise awareness about the Korean companies that have leading know-hows, and thus potential partners in global business community would screen cooperation opportunities.
